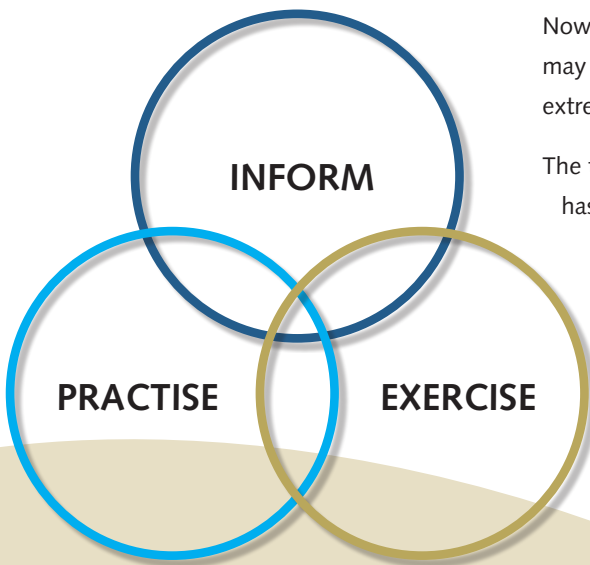




Counter Terrorism Awareness Training



Globally the Improvised Explosive Device (IED) is the weapon of choice for terrorist organisations. To counter this developing threat it is essential for those involved in the safety and security industry to keep abreast of the evolving *modus operandi* and technical developments employed by such organisations, and to have realistic and objective training to tackle this issue.

Who is this course for?

In today's world terrorism awareness and prevention, coupled with training, is becoming ever more vital. Why should I take this course?

Nowadays the threat of a terrorist attack is a very real and serious danger. We may all be a potential target for terrorists, from large scale coordinated attacks by extremist organisations to hate campaigns waged by individuals.

The traditional view of a terror campaign being targeted at government locations has changed, and it is now acknowledged that it is the public which is often the terrorist's target. In particular, crowded locations, such as public transport and shopping centres where large numbers of people gather, have become key targets of choice for these individuals.

This course has been specifically created to help meet this need and allow individuals and organisations to better understand their role and what steps they can take in the fight against terror.

An awareness of the methodology and key indicators within the cycle of a terrorist attack is paramount to competently prepare, prevent and respond to such acts. These key concepts are delivered by Rutherford Training Consultants through a partnership of continual progressive improvement with industry stakeholders.



What does the course cover?

This one day programme has been designed to give delegates an understanding of both the history of terrorism, as well as the factors that drive people to resort to terrorist activity. A key part of the training also focuses on examining the differing methods and devices that terrorists may employ to achieve their aims. The training also examines the steps an individual or organisation can take to attempt to identify the level of threat they might be facing, and explores what steps you can undertake to counteract and reduce this threat. - ♥ Risk reduction measures to reduce the threat you face
- ♥ The importance of incident management planning
- ♥ Post attack or incident considerations
