However it goes much further than that, as a door supervisor you are the first contact that customers have with your venue, so you play an important part in the image of the venue. Also you are responsible for ensuring the safety of your customers by preventing drugs or weapons from entering the building.

Do I have to take an exam to pass the course?

Yes, there are two multiple-choice examinations, and candidates must pass both exams in order to successfully complete the course.

The first exam tests candidates understanding of their role and responsibilities as a door supervisor and the second exam tests their conflict management skills.

Will I get a certificate if I pass?

Yes. Once the exams have been independently marked, which takes around two weeks, candidates receive a certificate accredited by Skills for Security.
